Once complete, we begin terminating a low volume of live calls for 5 days in order for us to test the inbound originating and outbound terminating call quality. We run QOS verification sweeps and send you a sample billing for the CDR's we have processed to ensure they match your records. That's it... we could not make it any easier if we tried. Don't forget that you will have access to great tools and reports in the Member Area, and your Finance contact will have special access to a more in depth portal allowing them to review and pay invoices.


